# **Federal Patent Court**

## **Executive Summary**

At 22, the number of incoming cases remained virtually unchanged compared to the previous year (21 in the previous year). The number of ordinary proceedings increased (18, 13 in the previous year), while the number of summary proceedings decreased (4, 8 in the previous year).

During the reporting year, the Federal Patent Court handled 14 ordinary proceedings, of which two were settled and seven terminated by judgment. One set of proceedings was not admitted and four were declared groundless. A total of three summary proceedings were disposed of during the reporting year, of which one was terminated by judgment and two were declared groundless. The number of cases pending by the end of the year increased slightly (25, 21 in the previous year).

At CHF 796,605, income was down on the all-time high of the previous year (CHF 1,051,936) due to fewer cases being terminated. As expenses were also considerably lower (CHF 1,566,306, CHF 1,753,918 in the previous year), the coverage ratio is still a considerable 51% (all-time high of 60% in the previous year).

## Caseload

By the end of 2020, 24 ordinary proceedings and one summary proceeding were pending at the Federal Patent Court (20 and 0 in the previous year).

At 22, the number of incoming cases remained virtually unchanged compared to the previous year (21 in the previous year). The number of ordinary proceedings increased (18, 13 in the previous year), while the number of summary proceedings decreased (4, 8 in the previous year).

During the reporting year, the Federal Patent Court disposed of 14 ordinary proceedings (30 in the previous year), of which 2 were settled (7 in the previous year), 4 were declared groundless (8 in the previous year), 7 were terminated by judgment (15 in the previous year) and 1 was not admitted (0 in the previous year). The Administrative Commission ruled on 1 request for a recusal. 7 substantive judgments and the decision by the Administrative Commission were appealed to the Federal Supreme Court (for 2 substantive judgments, the period for filing an appeal is still ongoing). In the reporting year, the Federal Patent Court handled 11 appeals against decisions by the Federal Patent Court, including 6 against decisions made in 2019. 8 appeals were rejected, 1 was approved, 1 case was sent back for further clarification and 1 appeal was declared groundless. 3 appeals were still pending at the end of the reporting year.

A total of 3 summary proceedings were disposed of in the reporting year (10 in the previous year), of which 1 was terminated by judgment (8 in the previous year) and 2 were declared groundless.

## Non-permanent judges

The system of non-permanent judges with technical training still proves to be extremely effective. The possibility of composing panels of qualified legal and technical experts from a given field ensures that these panels are highly competent and able to dispose of technically complex cases in an appropriate amount of time and at reasonable costs.

The number of cases in which the President recused himself fell further to just 4 by the end of the reporting year. 2 cases were received before the end of 2017 and are thus expected to be terminated soon. The President recused himself from one case received during the reporting year, which is related to one of the cases pending since 2017.

## Languages

During the reporting year, all 18 of the ordinary proceedings submitted to the Federal Patent Court were handled in German. There were no cases in French or Italian. In summary proceedings, German was used in three cases and French in one case. There were no cases in Italian. In two ordinary proceedings and two summary proceedings, litigants mutually agreed to invoke the legal right conferred upon them by the Federal Patent Court Act to use English in submissions and hearings instead of an official language of Switzerland. Of the 72 protective briefs, 23 were submitted in English. Parties clearly show great interest in pleading their cases in English. This can be explained by the fact that English is the working language used not just by many foreign companies involved in court cases here but also by the R&D and patent divisions of a number of Swiss companies, and that frequently the main state-of-the-art documents are also in English.

## Administrative office

The staff continues to comprise two office employees (equivalent to a combined work week percentage of 130%) and two clerks (equivalent to a combined work week percentage of 100%). The second court clerk, whose main role is as court clerk in Division II of the Federal Administrative Court, is brought in on a case-by-case basis when required.

## **Premises**

The office space of the Federal Patent Court, like the hearing rooms that the Federal Administrative Court shares with the Federal Patent Court, serve their intended purpose; there is no need to change the current arrangements.

When the Federal Patent Court needs to conduct proceedings away from St. Gallen, the cantons where the hearings are to be held provide the hearing rooms. Two instructional hearings were held in the courtroom of the Hôtel de Ville in Neuchâtel during the reporting year. This was greatly appreciated by the parties, who were based in the Frenchspeaking part of Switzerland.

## Finances

The profit and loss statement of the Federal Patent Court shows expenditure down 11% to CHF 1,566,306 (previous year CHF 1,753,918). The fall in expenses is due to the lower number of cases terminated, fewer recusals on the part of the President and the fact that plenary sessions were cancelled or held virtually, all of which reduced the compensation paid to the non-permanent judges. At CHF 796,605, income was also down on the previous year due to fewer cases being terminated (previous year CHF 1,051,936). However, the previous year's figure had been an all-time hiah.

The remaining amount to be covered by the IPI according to Article 4 PatCA therefore stands at CHF 769,700 (previous year CHF 701,982). The increase in this amount can be attributed to a fall in the number of cases terminated compared to the record year of 2019, resulting in less income from court fees.

## Effects of the Covid-19 pandemic

The Covid-19 pandemic had only a minor impact on court proceedings. No hearings were held during the first lockdown in spring 2020 and the extraordinary extension period for court vacations. In-person hearings have since resumed with protective measures in place (social distancing, face coverings, perspex screens). The Federal Patent Court rejected requests for instructional hearings to be broadcast abroad by video conference for participants who could not be present due to entry restrictions, making reference to the confidential nature of the settlement discussions. The risk of infection in the workplace is low as only three people are present in the St. Gallen office on a typical working day – the non-permanent judges are only there on hearing days. The spring plenary session was cancelled. The autumn plenary session was held in a significantly slimmed-down format by video conference – this was possible because there was no elections tabulated.

## Cooperation

The Federal Patent Court greatly appreciates the support that it received in supervisory meetings with the Federal Supreme Court via video conference on 3 April and in St. Gallen on 9 October.

As in previous years, cooperation with the Federal Administrative Court went very smoothly operative levels. In its discussions with the President and Executive Secretary of the Federal Administrative Court, the Federal Patent Court stressed that it would like to be involved in planning Federal Administrative Court projects that directly affect the Federal Patent Court early on. Above all, this concerns equipping the courtrooms which are mainly used by the Federal Patent Court and the business administration software for which the Federal Patent Court obtains IT services from the Federal Administrative Court in accordance with the service agreement.





#### Cases by language of proceedings in 2020




#### Approach used to settle cases in 2020 (regular proceedings)

#### Cases by technical field


